The Stewardship Centre for BC (SCBC) is working to build capacity within individual stewardship organizations and across the sector as a whole. Previously, SCBC led a team of consultants and advisors who designed an eight-part framework for building capacity in BC's environmental stewardship community. The *Capacity Building Framework* provides the stewardship community with a common platform for discussing eight aspects of capacity building. The current project (2010-2011) created tools and resources to for the eight parts of the framework.

2010/2011 Project Objectives were:

- To collect and share new capacity building knowledge within environmental stewardship audiences
- To increase the capacity of stewardship organizations to deliver environmental and social benefits in

their communities and across BC

• To engage diverse stakeholders in collaboratively growing, maintaining, and delivering resources that build capacity in the environmental stewardship sector.

To meet the above project objectives project activities centred around communications work, development of capacity building tools, resources and best practices, and development of a web-based platform to engage diverse stakeholders in the stewardship community. The results included the development of a capacity building web-based benchmarking tool on a dedicated website (linked to the SCBC site), a collaborative workshop to gather feedback and deliver resources, development of a data-base of resources and tools for capacity building and best practices. Together, these support the BC stewardship community to effectively fulfil their mandates.

The Stewardship Centre for BC (SCBC) is working to build capacity within individual stewardship organizations and across the sector as a whole. The *Capacity Building Framework* provides the stewardship community with a common platform for discussing eight aspects of capacity building. Four preliminary steps are recommended in order to begin to build momentum and support for ongoing support for the stewardship community. Based on the interest expressed during the workshop and on the feedback forms, several participants indicated that they would like to be involved in further discussions about a strategy for seeking core funding for stewardship and conservation groups in BC. As a starting point, a conference call between interested individuals, and the StewardshipWorks! advisory committee could determine priority action items and responsibilities.

On-Line Benchmarking Tool

The next step in this process is to assist stewardship organizations to work through the benchmarking tool and to assist them to create a strategy to further increase their organization's capabilities. It is recommended that a facilitator work directly with stewardship organizations to assess their organizational capacity using a newly developed Capacity Building Benchmarking Tool. Following assessment the organizations would work with the facilitator to develop a customized action plan to help guide them through future capacity development activities. This will result in a stable, effective, and efficient stewardship sector, better able to achieve their organizational objectives.

3.6. What are the top three lessons learned from this project that could be useful to communicate to others doing similar work in the Basin?

- 1. We learned some technical lessons both positive and negative about ways to communicate within our own organization and with others. The Benchmarking on-line Tool was more challenging to get up and running due to hardware/software issues with our host server's structure. This required more technical time and thinking outside the box. We are very excited about the tool itself however!
- 2. BM Tool is very much needed and very useful to the BC stewardship community. We heard feedback that users will use tool to be work more strategically (work smarter not harder).
- 3. While developing the new tools and resources we realized that we needed to boost our own capacity too and applied the lessons to our own organization with very worthwhile results.

Sharing and exchanging knowledge and resources for capacity building was integral to the Strengthening Stewardship project in 2010-2011. Communications and outreach activities included:

- Ongoing engagement and consultation with the Advisory Group, through conference calls, meetings, one-on-one discussions, and workshop participation.
- Knowledge transfer involving at least 30 stewardship organizations including telephone interviews, conference calls, personal meetings, on-line feedback, and workshop participation.
- Strengthening Stewardship collaborative Workshop was held that shared information and experiences about capacity building resources and implementation processes with key government agencies, stewardship organizations, not-for profit capacity builders, and funders.
- Web-based information hub is now available to collect and exchange capacity building knowledge and resources.
