The Stewardship Centre for BC (SCBC) developed the Stewardship Works! program in order to increase the capacity of conservation and stewardship organizations in B.C. who are critical to conserving, protecting and restoring BC's fish, wildlife, and their habitats and biodiversity values. Stewardship Works! funded one organization in each of ten regions in BC with small annual core funding grants and evaluated the impact of increased capacity on conservation efforts, through regular reporting and telephone interviews. The result was that Stewardship Works! increased the ability of the recipients to attract and maintain volunteers, acquire other funding, impact local government, and create community connections and partnerships. The core funding also increased stability, enhanced board support, and reduced burn-out.

SCBC has demonstrated and quantified the benefits of providing core funding to stewardship organizations by contracting an evaluation specialist who has remained in contact with the groups and regularly interviewed them and wrote both progress reports and a final report. Now that the 3-year pilot has been completed, a more in-depth report and strategy will be developed to promote the future

success of the Stewardship Works! program.

One of the outcomes of providing core funding to stewardship organizations has been that the groups were able to attract and support more volunteers to participate in stewardship activities – thus increasing wildlife and conservation efforts.

SCBC will be hosting a workshop in September 2010 with stewardship organizations, funders and various levels of government to educate about the importance of capacity building, encourage dialogue and action among stakeholders, identify and create partnership opportunities and identify the capacity building needs of stewardship organizations in B.C.

SCBC has also contracted someone to liaise with funding agencies and organizations to underscore the need to fund capacity building programs and to find opportunities for partnership projects.

In addition, the SCBC website is being redeveloped to provide more and better tools to the stewardship community.
