The Watershed Communications project was meant to increase information sharing within the community around issues, concerns, programs, opportunities for collaboration and local projects. The objectives were to provide information for better decision making, initiate new partnerships and to help all parties leverage time and resources.

Results included:

- A new working partnership with the Lhtako Dene Nation on the Dragon Creek Restoration and Management.
- Working with the Cariboo Regional District on: bringing in a speaker related to local watershed issues and climate change for Forest Capital of Canada event, Dragon Creek Restoration and Management, increased promotion for equipment operators riparian education workshops.
- Potential to work with the Native Friendship Centre on nature tourism opportunities.
- Participation in OCP Fringe area planning with CRD around riparian areas.
- Planning with City of Quesnel which led to: Farmers Market promotion of sustainable living, Winter

Festival (1230 participants to stations such as Salt Water Tank Introduction, Salmon Life-Cycle, and Bird Watching), Earth Week (working with Downtown Association and City on an Earth Day Run and local business advertising their green initiatives through earth week), Sustainability Planning at the Corporate and Community Level.

This funding allowed our society to stay up to date on watershed issues and information from City of Quesnel, and the Cariboo Regional District in particular. This has also allowed us to keep our City and Regional District up to date with our projects, challenges and initiatives which has led to a better understanding of our projects and leveraging of resources for things like our Winter Festival Watershed Education Programming, Earth Week Initiatives, Climate Action Speakers for the community, and projects like our Riparian Logic Modeling – Equipment Operators workshops, Dragon Creek Culvert replacement and Salmon Statues on all Fraser River Crossings.

This funding has also allowed us to initiate a relationship with the Native Friendship Centre and the Lhtako Dene Nation that is ongoing. We are currently working towards increased habitat access and multi-stakeholder management of Dragon Creek, as well we are working on developing some potential tourism activities on Baker Creek that would include both environmental and cultural tourism assets.

Only had one contact with representation from the Indo Canadian Community and there were plans to support a creek clean up that goes right by a local temple. This did not happen and no further events or projects were planned. This was due mainly to scheduling difficulties.

The increased communication has led to informed decision making, increased collaboration, increased leveraging or money and time, and new partnerships that otherwise would not have happened. Relationships take time to build and as a ENGO there is no budget to engage in this way and some of the discussions need to be from a consistent staff person that has the appropriate background and expertise.
