Strengthen community-based stewardship organizations by providing them with the resources, training, and funding required to enable them to protect and conserve species and habitats.

Through this project, stewardship organizations are being provided with tools to build the capacity of their organizations and thus be able to better achieve their mandates. The first tool that has been developed are the Capacity Benchmarking Tool which enables organizations to self-assess the capacity of their organization and identify priorities for action. The second tool is complementary – a database of capacity building resources that stewardship organizations can turn to once they have identified their capacity building needs. The database will be online and searchable.

The capacity building workshop in Sept. 2010 will provide an opportunity to promote these tools and also gain feedback to be able to provide the stewardship sector with the best possible resources.

SCBC is developing an online hub of capacity building information, resources and tools for the stewardship sector.

SCBC is also participating and contributing to the newly formed Capacity Building Consortium – a network of capacity building organizations. This new Consortium of capacity builders has much to share, and the stewardship community could benefit from the expertise of the participating organizations from all sectors of the non-profit and corporate sectors.

SCBC has also contracted someone to liaise with funding agencies and organizations to underscore the need to fund capacity building programs and to find opportunities for partnership projects.

In addition, the SCBC website is being redeveloped to provide more and better tools to the stewardship community.
