Project Summary

To understand the changes to watershed shed and impacts to wild Salmon and Stó:lō First Nations , and contributing factors

We met with community members over the period of 8 months the purpose of these meeting was to develop a community understanding of changes and impacts to both Salmon and Stó:lō First Nations, TEK research with Stó:lō resource centre to gather Ethnohistory of Stó:lō First Nations linkage to the Salmon.

The Framework That was used to engage Stó:lō First Nations communities helped us understand, past, present, future, salmon patterns and to develop short- term and long term goals with communities workshops helped take a deeper look at what type of relationship building needs to take place for future planning, how we cope with current conditions. Some partnership was undertaken with other community groups, a technical presentation of Chum Salmon population within the Fraser Valley to help with referrals process for technical

Activity

Food Security- meetings:

We met with 8-10 community members on a regular basis, the subject food security was a very sensitive issue for these members. There was lots of frustration at first but once we went through the steps, I watched the group grow from the experience. After many meetings the group had conducted their own analysis of how communities engaged with other users, and what Ideals they would like to see grow from this project. At the end of the framework the group was so empowered from the experience and there was a definite commitment to be more pro-active in finding solutions and working together with other communities. Over all we achieved a lot more than what I expected and their commitment to continue into the future was refreshing.
